- For reporting purposes, please indicate whether the organisation is Catholic or faith-based.
  - If yes, please provide brief details
- Does the organisation have an existing relationship with ACU?
  - If yes, please provide brief details
- For reporting purposes, please indicate if you have consulted with any ACU staff about your EOI?

### 3. ABOUT THE RESEARCH PROJECT
