

SENATE DIGEST FOR MEETING OF 3 APRIL 2024

1. Welcome and Apologies

The Chancellor welcomed Senators and attendees to the meeting and apologies were noted.

2. Report from Chancellor

The Chancellor observed that the written Report contains a summary of the events and meetings in which he had participated since the previous meeting and highlighted his attendance at the Evening Easter Vigil at the Holy Spirit Chapel on the Banyo Campus.

3. Report from Vice-Chancellor and President

The Vice-Chancellor and President (VC) provided an overview of the written Report and highlighted the following:

- A VC-led ACU delegation visited Nepal and India with the primary objective of establishing and fostering relationships with educational institutions, Government officials and local industry representatives;
- Signing of memorandum of understanding with the Kathmandu University;
- Increased activity in research innovation and commercialisation, with a number of projects on the cusp of commercialisation and spin-off; and
- ACU's citation performance remaining high.
