

Australian Catholic University Student Services and Amenities Fee (SSAF) 2022 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister. Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this SSAF Allocation Report does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP (FVI)</u> for all other approved providers.

SSAF CONSULTATION AND ACHIEVEMENTS

In line with the Commonwealth guidelines for SSAF spending and student consultation, timely surveys and consultations were conducted to identify key priorities for the use of SSAF funds. The SSAF long-term strategic priority areas for funding at ACU are as follows:

- Wellbeing
- Belonging
- Support
- · Catholic University measurement
- Engagement
- Facilities

Each year the University consults with students about the priorities for SSAF expenditure. This includes formal discussions with elected student leaders from the ACU National Student Association (ACUNSA) and the ACU Postgraduate Association (ACUPGA). In 2022 the University consulted with relevant stakeholders, including student bodies and individual students to ensure their needs were understood, prioritised and addressed. Additionally, a SSAF survey was sent to all students in September 2022, with a response rate of 8.81%. This compares to 11.5% for the September 2021 survey response rate.

ACU meets this obligation through quarterly meetings between senior management and the ACU National Student Association (ACUNSA). ACUNSA's makeup (national president, campus student association presidents, Post Graduate Association president and international representative) ensures a broad representation of student opinion.

Additional to this ACU Sport, ACU Active and the ACU Elite Athlete and Performer program also have a number of feedback mechanisms through Club committees and feedback mechanisms in place including Net Promotor Scores NPS to ascertain student feedback on particular programs

¹ Note: As per Part 2 of the *Higher Education Support (Administration) Guidelines 2022* (Administration Guidelines), students studying on a part-time basis must not be charged more than 75 per cent of the maximum SSAF that a higher education provider determines for students studying on a full-time basis. The term "part-time basis" means a study load of less than 75 per cent of the normal full-time student load for the period to which the fee relates. As per part 7 of the Administration Guidelines, the normal EFTSL value for a full-time student studying over a period of one year is 1.0.

² Note: As per Part 2 of the Administration Guidelines, a higher education provider may choose to determine a different SSAF for particular categories of persons, including a zero amount.

³ Note: Students are categorised as full-time or part-time students based on the total EFTSL value of the units of study they undertook in [insert reported year]. For example, a student undertook a full-time study load in Semester 1 which was equal to 0.5 EFTSL and undertook a part-time study load in Semester 2 which was equal to 0.375 EFTSL. This student would be categorised as a full-time student in [insert reported year] as the total EFTSL they undertook in [insert reported year] was equal to 0.875.
